PROFESSIONAL EXPERIENCE/QUALIFICATIONS

Ms. Carr is NACE certified (#21886) coating inspector with over 16 years' experience in the coatings industry, including 12 years' experience as a coatings inspector with 10 of those years in a supervisory position. She has been intimately involved in numerous coatings projects involving both concrete and steel structures for many utilities, agencies, and owners. This experience primarily includes work on storage tanks, pipelines, and structural steel for the Gov't fuels, water, wastewater, and petrochemical industries.

Throughout Ms. Carr's career as a Quality Control Professional, she has been involved in the following items and tasks directly associate with the QP5 Program: inspections, review of DIR's, spot checks, processing CAR's, NCR's & rework logs and tracking until final closeout, QP internal & external audits, control of records & documents, training & qualifying QC personnel, maintaining tool & instrument calibration and most importantly development of FPI's QP5 QMS.

Ms. Carr is currently located on Guam performing QP5 Level III coating inspections as the Lead Inspector at Anderson Air Force Base JP-8 Fuel Storage Tank 4-1, and for the Navy at NAVSUP on the fuel distribution pipeline & valve pits for the island. RELATED WORK EXPERIENCE:

Ms. Carr's experience as a coating inspector includes work with inorganic zincs, epoxies, FBE, coal-tar enamels, coat-tar cut-back's, vinyls, urethanes, alkyds, acrylics, vinyl esters, PVC linings, and numerous other generic types of coatings that include 100% solids high-build materials. Her experiences include inspections for surface preparation techniques that include power tool cleaning, abrasive blasting, hydro-blasting, and acid etching in both shop and field operations on substrates that include steel, concrete, aluminum, masonry, and others. These experiences also include inspection operations involving airless, conventional, and plural component. Ms. Carr also has extensive experience with coating inspection instrumentation including pull-off adhesion testers, ultrasonic gages, moisture meters, holiday detectors, hardness gages, pH measuring instrumentation, voltmeter and various reference cells.
